**MINUTES OF A SPECIAL

The Special Meetings of the Board of Directors of the Robinson Ranch Metropolitan District was called and held Wednesday, November 17, 2021, at 5:00 p.m. via audio/video conference, in accordance with the Colorado law.

**ADMINISTRATIVE
ITEMS:**

Call to Order: Mr. Meggers noted that a quorum of the Board was present and confirmed their qualifications to serve, meeting called to order at 5:00 p.m.

Disclosure of Potential Conflicts of Interest: Attorney Miller advised the Board that pursuant to Colorado law, certain disclosures might be required prior to taking official action at the meeting. Each Board member confirmed the contents of written disclosures previously made, stating the fact and summary nature of any matters, as required under Colorado law, to permit official action to be taken at the meeting.

Director Trevey disclosed his interests as the owner of a vacant land contract to purchase property within the District. Director Trevey disclosed that he works for SPASCO of Colorado, LLC, an owner and developer of property within the District. Director Trevey also disclosed that he is a Board member of the Olde Town Metropolitan District. This disclosure is associated with approval of items on the agenda that may affect his interests.

Agenda: Upon motion duly made by Director Trevey, the agenda was approved, as presented.

DISCUSSION ITEMS:

Director Trevey explained to the property owner the proposal by the metro district to maintain the road and drainage ditch. The district manager will be contacting each owner for a one-on-one informational call. If an additional meeting with the attorney is needed a second call will be scheduled.

OTHER ITEMS:

Discuss on Status of Amendment to Service Plan and Acquisition of Easement to Add Covenant Control and Maintenance Powers to the District.

The district manager and director will be rewriting the letter and including a map of the district showing how the proposal will be maintaining only the road and drainage ditch.

The amendment to the service plan will need to have the consent of all property owner in order for the proposal to go forward.

There being no further business to come before the Board, upon motion and seconded, the Board unanimously voted to adjourn the meeting.
